1. CALL TO ORDER: Katie Olivo, CFAC Chair, called the meeting to order at 11:02am
2. APPROVAL OF AGENDA and PREVIOUS MINUTES:
3. PROPOSALS:
  - a. Cat II Fee Proposal- Instructionally Related Activities Fee
    - i. Reviewed IRA process
    - ii. Invited Jenny Bramer from Athletics to present on fee proposal
      1. Included video presentation from Katie Olivo explaining CFAC's role in the fee approval process

2. Another video was played explaining the importance of Athletics and the rising costs of the Athletics program
3. Athletics Fuels Academic Success – More funding leads to more athletics success and visibility which leads to strong rankings which leads to greater academic reputation and degree value
4. The fee will be used for -
  - a. Spirit Enhancements – Student engagement
  - b. Shared Facilities – Replacement, maintenance, and repairs of various facilities. Such as fields, gyms, athletic center
  - c. Internships, Practicums – Opportunities for students
  - d. Student Athlete Well Being – Nutrition, psychology, and medicine for student athletes
5. Fee and Budget
  - a. Proposed fee is an additional \$130 per semester
  - b. Will increase student fee support to athletics to 22% of total revenue
  - c. The new fee would put SDSU on par with other campuses in terms of student fee amount
6. Questions
  - a. Will student athletes be included in the presentation?
    - i. Yes. Including student athletes will help the presentation connect to students
  - b. Recommended to include more IV students. Possibly through more transportation to main campus events
  - c. Recommended to highlight the connection student athletes have with academics
  - d. Was there research done to other campuses revenue's generated from fees vs other revenue sources?
    - i. No. This information is public and could be added
  - e. Recommended to better clarify how athletics success could lead to academic success

- f. Recommended to elaborate on the donation correlation from athletics to other areas
- g. Recommended not including Lamont Butler’s “buzzer beater” moment, as current student might not remember this moment. Including a more well-rounded and recent accomplishments might resonate more with students.
